## Judge Swinford issues order enjoining Danville barbers to stop discrimination

Judge Mac Swinford of East District Federal Court issued a court order February 22, enjoining eight Danville barbers discriminating between their prospective patrons on account of race." The decision makes invalid a section of Kentucky law which exempts barbershops from public accomodations status. The decision may bring to a close action in the barbership discriminations case of Taylor, et. al. vs. Richardson, et. al. Ollie Taylor, Ray Burse, and Tommie Smith, the plaintiffs in the case, filed the class-active suit last

June after testing the Danville barbers to determine if they would serve blacks.

Reaction on campus to the decision was enthusiastic. Dean Max Cavnes, who helped in the testing of the bartbershops exclaimed, "I'm delighted! I'm a bad loser and I'm glad we won."

He felt that the black citizens of Danville should have pressed for

this action rather than Centre students because, "It puts the barbers against the college." Professor David Hughes, who teaches constitutional law at Centre, declared that he was

pleased with the result in the case." He added, though, that "he was dubious about the use of precedent in

reaching the decision."

Ollie Taylor, bubbling with excitement, said that he will send the results to the Human CRRights Commission in Louisville, hoping that similar action could be taken "to liberate the Western District of the state." He added, "Eventually I will do something about segregation in barbershops in Mobile," his home city. Reminiscing, Taylor recalled that it was then Centre students Jerry Wakefield and Randall Bausor who encouraged him "to do

something about Danville bar-

Included in a notice of the results of the case sent to Taylor by attorney Elwood Rosenbaum, who handled the case without charging legal fees, a nine page memoran-dum reads in part: "It is the plaintiff's contention that the defendants, various Danville barbers and barbershop proprietors, have . . . refused, on account of race, to render their services to the persons of the plaintiffs.

defendants have refused to render their services to the plaintiffs on account of the plaintiffs' race. It is insinuated that the plaintiffs are officious intermeddlers. Moreover, it is suggested that the defendants are not capable of performing their tonsorial crafts upon the Negro head. The two sallies beg the question. Whether or not the plaintiffs are "troublemakers" is irrelevant, and the competency of the defendants is not here in issue."

The court based its decision on the 14th amendment to the U. S. Consituation applying the "State action" interpretation of that amendment to this case. According to the memorandum, "The central legal issue of this case resolves to a question of whether the defendant may, under the Fourteenth Amendment and Section 1983 of Title 42, be permitted by the state to discriminate on account of race in the practice of a profession which is strictly regulated by the State and which appeals to the general public for its economic preservation. Stated difficultly, the issue is whether the dicriminatory acts of the defendants. . .may be considered

to be sufficiently connected to the State so as to be enjoinable under the Fourteenth Amendment of the Constitution. The court believes that the defendants may be enjoined from descriminating between their patrons solely on the basis of race."

The court reasoned the licensing and "substantial" regulation by the State of barbershops makes the action of the barbers "sufficiently imbued with state authority so as to bring it within the an-discriminatory coverage of the Fourteenth Amendment, 'Precedent in this case was a concurring decision by Mr. Justice Douglas in the case of Garner vs. Louisiana. He stated "I do not believe that a State that licenses a business can license it to serve only whites or only blacks or only yellows or only browns. . . I do not see how a state can constitutionally exercise its licensing power over a business either in terms or in effect to segregate the races in the licensed premises. The authority to license a business for public use is derived from the public. Negroes are as much a part of that public as are whites."
